Sub: Relief of OAS-I(JB) Officers under orders of transfer.

Madam/ Sir,

I am to reiterate instructions issued earlier and to say that inspite of clear instructions a good number of officers under orders of transfer vide this Department Notification No. 33795 dated 2.9.2013 have not yet been relieved by the Controlling Authorities, which has caused administrative inconvenience and dis-location in Government works. Government have expressed their deep concern in the matter.


It is therefore, once again impressed upon all concerned to relieve these officers by 1.10.13 positively with the instruction to join their new place of posting by the end of 1st week of October, 2013.

The officers under orders of transfer are also instructed to get themselves relieved by relinquishing charges by 1.10.13 positively (if not relieved by their authorities) failing which action for major penalty proceeding under rule-15 will be resorted to. The Director, Treasuries is

being requested to issue instructions to the concerned treasury officers not allow drawl of salary of officers from the places they have been transferred.

All the officers under orders of transfer will be deemed to have been relieved w.e.f. 1.10.2013.


