
In the meeting representative of NIC, OCAC, STPI were present. The list of participants of the meeting is annexed at Annexure-A.

He appraised that, to implement the e-Governance initiatives of Revenue & DM Department the field functionaries shall be provided with good quality computer, laptop and printer etc with latest configuration.






It was inferred that various application softwares such as e-District, Bhulekh, LRMS, RCCMS, BhuNaksha, MTA, DWIST, CCMS have been implemented by the Department. However, good quality computer / laptop was not yet provided to RIs/ARIs and Tahasildars. Therefore, the computers and laptops which will be supplied to all Tahsils and RI Offices must be of latest configuration.

After a detailed discussion on the requirement and future roadmap, it was decided that computer / laptop which will be provided to RI or Tahsil office must be of latest configuration such as I7 processor and 7<sup>th</sup> generation system.
